- **19. 'Eligible HSBC easy Credit Card'** means any Hong Kong Dollar personal primary, combined additional, separate additional HSBC easy Credit Cards issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns).

'Eligible HSBC Visa Platinum Credit Card' means any Hong Kong Dollar personal primary, combined additional, separate additional Visa Platinum credit cards issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns). HSBC green Credit Card is excluded.

- 24. **'Watsons eShop Account'** means your membership account at the website/mobile application of the Watsons' eShop operated by AS Watson Group.
